# **ELIGIBILITY REQUIREMENTS**

- This Exhibition is open to all PPSCC members.
- 80% of the exposed surface must be dry pastel. No oil pastels.
- There is no size limitation.
- Must be entirely the work of the artist and not copied from other artists' work, photos or publications.
- Must not have been created under supervision (as in a workshop or class).
- If the work is not for sale, check "NFS" on the entry form.

# ENTRY FEES

\$30 for up to three images \$10 each for additional entries for a total of 6 entries allowed per artist.

# **ENTRY PROCESS**

- Online entry using Online Juried Shows
- Go to www.onlinejuriedshows.com and sign in or register a user account.
- Up to 6 images may be submitted.
- No file-naming restrictions. Juror will not see the file name.
- JPEGs must not show mat, frame, etc., and must be an accurate representation of the artwork.

- Entry form must be filled out in its entirety. List sizes up to the nearest inch. Submitted images must not include matting or frame. Crop the photos to include only the artwork. Be sure your images are right-side-up.
- Before uploading your images, make sure they are smaller than 4MB, but at least 1920 pixels on the longest side at 72 dpi. Images should be in JPEG format, RGB color space.
